The guarantee objects are as follows:

- payment of amount necessary for continuation of the package travel or repatriation cost, especially transport and accommodation, incl. also justified costs borne by the travelers in the case when the Applicant, contrary to his obligation, does not ensure continuation or repatriation;
- refund of package travel costs or of each service paid to the trader facilitating linked travel arrangements where, for reasons related to the Applicant or persons acting on his behalf, the package travel or any service paid to the trader facilitating linked travel arrangements has not been or will not be executed;
- partially refund of package travel costs corresponding to the part of the package travel or of each service paid to trader facilitating linked travel arrangements corresponding to the part of the service that has not been or will not be executed for reasons related to the Applicant or persons acting on his behalf.

The guarantee sum amounts to
227.425,00 PLN

Which is an equivalent of 50.000,00 EURO (in words: fifty thousand 00/100 EURO) calculated on the base of the average rate of exchange published by the Polish National Bank for the first time in the year when the guarantee was issued, i.e. on 4th of January 2021 (1 EUR= 4,5485 PLN).

The obligations of the Guarantor include the following types of activities performed by the Applicant:

- 1) organization of package travels in the territory of non-European countries listed in the Annex to the Regulation using a means of transport other than air transport as part of charter transport;
- 2) organization of package travels in the territory of non-European countries by means of transport other than air transport by charter;
- 3) organization of package travels on the territory of the European countries listed in the Annex to the Regulation using a means of transport other than air transport as part of charter transport, excluding organization of package travels on the territory of the countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast, and on the territory of the Republic of Poland, if a transport service is provided;
- 4) organization of package travels on the territory of the European countries listed in the Annex to the Regulation, if no transport service is provided, with the exception of the organization of tourist events in the territory of the countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast, and on the territory of the Republic of Poland, if no transport service is provided;
- 5) organization of package travels on the territory of countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast, and on the territory of the Republic of Poland, if a transport service is provided;
- 6) organization of package travels on the territory of countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast and on the territory of the Republic of Poland, if no transport service is provided;
- 7) facilitating the linked travel arrangements carried out on the territory of non-European countries, if a transport service is provided;
- 8) facilitating the linked travel arrangements carried out on the territory of non-European countries, if no transport service is provided;
- 9) facilitating linked travel arrangements provided on the territory of European countries listed in the Annex to the Regulation, if a transport service is provided, with the exception of facilitating the purchase of linked travel arrangements provided on the territory of countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast and on the territory of the Republic of Poland, if a transport service is provided;
- 10) facilitating linked travel arrangements provided on the territory of the European countries listed in the Annex to the Regulation, if no transport service is provided, with the exception of facilitating linked travel arrangements provided on the territory of the countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast and on the territory of Poland, if no transport service is provided;
- 11) facilitating linked travel arrangements provided on the territory of countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast and on the territory of the Republic of Poland, if a transport service is provided;
- 12) facilitating linked travel arrangements provided on the territory of countries having a land border with the Republic of Poland, and in the case of the Russian Federation - within the Kaliningrad Oblast and on the territory of the Republic of Poland, if a transport service is provided;
